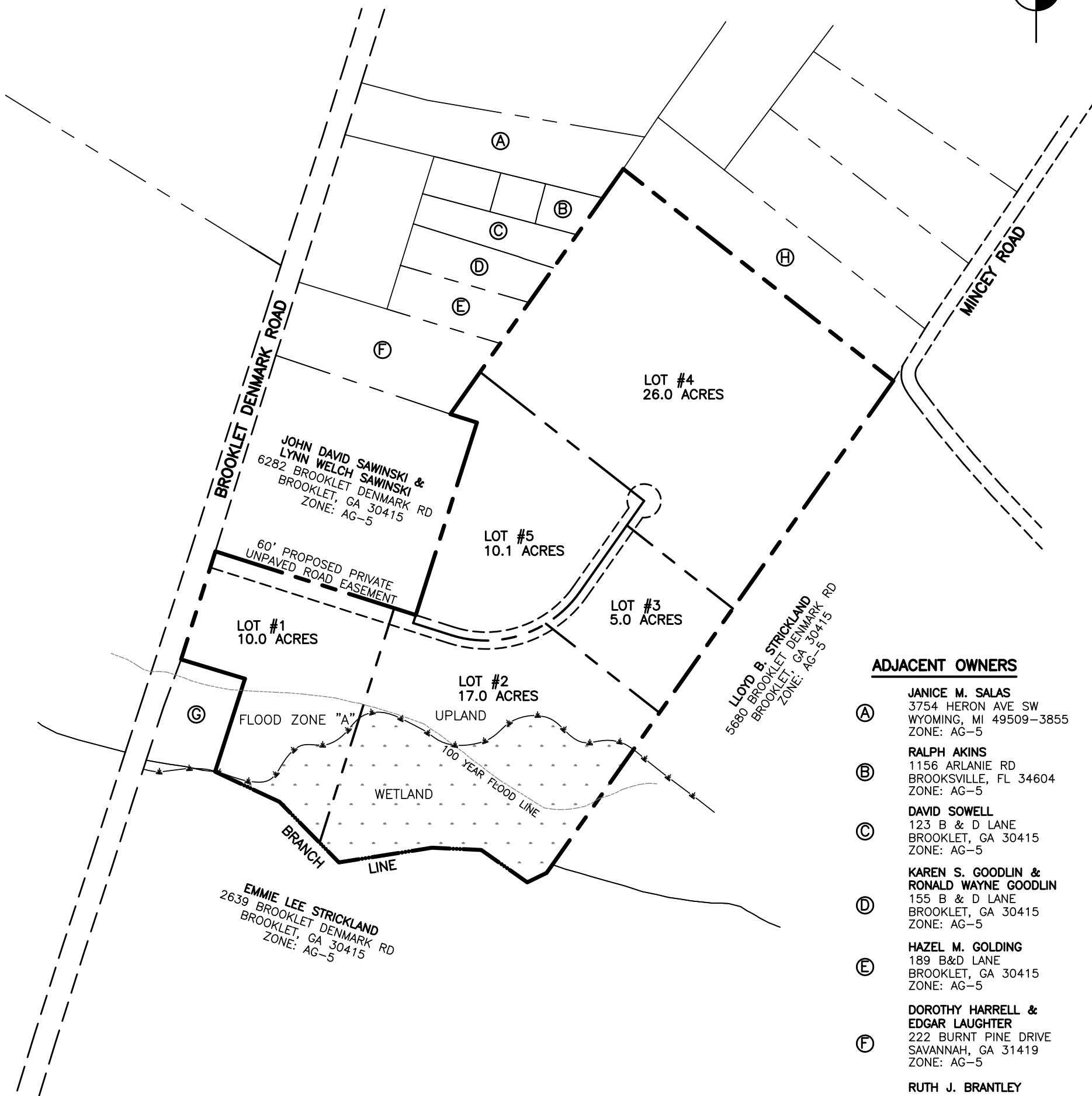
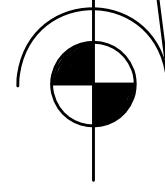


VICINITY MAP - N.T.S.
